**4. FIRST AID MEASURES****General advice**

### Skin contact

Wash off immediately with soap and plenty of water. If symptoms persist, call a physician.

### Eye contact

In case of eye contact, remove contact lens and rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention if irritation develops and persists.

### Ingestion

Induce vomiting only, if: 1. patient is fully conscious, 2. medical aid is not readily available, 3. a significant amount (more than a mouthful) has been ingested and 4. time since ingestion is less than 1 hour. (Vomit should not get into the respiratory tract.) Rinse mouth. Call a physician or poison control center immediately.

### Notes to Physician

#### Treatment

Treat symptomatically.

Monitor: respiratory and cardiac functions.

Gastric lavage is not normally required. However, if a significant amount (more than a mouthful) has been ingested, administer activated charcoal and sodium sulphate.
